Notice of Information Practices:

To issue an insurance policy, we may need to obtain additional information about You and any other persons proposed for insurance. Some information will come from You and some may come from other sources. That information and any other subsequent information collected by Us may in some circumstances be disclosed to third parties without Your specific consent. You have the right to access and correct the information collected about You except information that relates to a claim or to a civil or criminal proceeding. If You wish to have a more detailed explanation of our information practices, please submit a written request to Us. This notice applies only in Arizona, California, Georgia, Illinios, Maine, Minnesota, Montana, Nevada, North Carolina, Oregon and Virginia.

Authorization to Obtain Information:

National Guardian Life Insurance Company, or its authorized representative, may obtain medical information about me in order to evaluate my application for disability insurance. I hereby authorize any licensed physician, medical practitioner, hospital, clinic, medical laboratory or other medically-related facility, the Veterans Administration, insurance company or its reinsurers that has any records or knowledge about medical care, treatment, diagnosis or advice rendered to me to give to (Insurance Company), its reinsurer or authorized representative, any such information in the event National Guardian Life Insurance Company finds such information necessary. This Authorization shall be valid for 30 months from the date shown below. A photocopy of this authorization shall be as valid as the original.
